



ADOPT-A-HOLIDAY PROGRAM

During each year, there are 10 holidays Meals on Wheels Yolo County is closed, and we provide a bag lunch for that day (delivered the day before along with a regular hot meal) to our home delivery clients, so they don't miss a meal.

As a sponsor of one of these 10 holidays, your donation helps us to provide a more robust meal with extra nutrition (maybe more protein for later in the day, some healthy snacks, some pieces of fresh fruit, a treat), as well as a couple of extras (flags for 4th of July, for example) to make the meal special for the holiday.

Also, there will be a flyer inside each lunch that day that gives your organization a shout-out for your donation (another reason we need your logo!). Some organizations also enjoy being "hands-on". If your group would like to come to our facility and pack the lunches as well, we will organize and set up the bags and all the ingredients, and your team of 5-7 folks can pack them up! It only takes about 90 minutes and is a great teambuilding activity! (Usually, this occurs a few business days before the actual holiday.)
